

**PUBLIC PRIVATE PARTNERSHIP FORUM
SPECIAL MEASURES AGREEMENT**

GLOBAL MILLENNIUM DEVELOPMENT FOUNDATION

A 501(C)(3) ORGANIZATION IN SPECIAL CONSULTATIVE STATUS WITH THE NGO
BRANCH OF THE DEPARTMENT OF ECONOMIC AND SOCIAL AFFAIRS OF THE
UNITED NATIONS, A STATUS WHICH WAS GRANTED FOR HAVING A SPECIAL
COMPETENCE IN FIELDS OF ACTIVITY COVERED BY THE UNITED NATIONS
ECONOMIC AND SOCIAL COUNCIL.

THIS SPECIAL MEASURES AGREEMENT (“AGREEMENT”) IS BETWEEN PUBLIC PRIVATE PARTNERSHIP FORUM (“P3 FORUM”), A PROGRAM OF GLOBAL MILLENNIUM DEVELOPMENT FOUNDATION, AND THE UNDERSIGNED SPECIAL MEASURE APPLICANT (“APPLICANT”). BY SIGNING BELOW, YOU AGREE THAT YOU HAVE READ AND UNDERSTOOD THE TERMS AND CONDITIONS.

SECTION I. MEMBERSHIP

Applicants shall only be approved for Special Measures status with P3 Forum upon written notice from the Executive Director(s). Status is a three (3) month or twelve (12) month contractual privilege to use the consulting services provided by P3 Forum on an as-is basis and participate in sponsored activities and events offered. Your status does not entitle you to any ownership in P3 Forum.

SECTION II. PAYMENTS

Members agree to pay the pledge amount of \$100,000 per quarter or \$300,000 per annum to P3 Forum for Special Measure status, payment for which is required upon signing to initiate the quarterly (3 month) or annual (12 month) membership. All payments under this agreement shall be made by electronic funds transfer to:

Once payment has settled, P3 Forum will provide a Donation Receipt from the foundation to be used for the purposes of tax deduction in accordance with its 501(c)(3) tax-exempt status with the Internal Revenue Service.

Minimum pledge amounts are subject to change as deemed necessary by P3 Forum.

SECTION III. CANCELLATION

Cancellation by Member - You may cancel your Membership at any time by giving the Executive Director(s) of P3 Forum thirty (30) days advance written notice. All payments are non-refundable, even if a Member fails to use the services provided by P3 Forum or participate in any of P3 Forum’s sponsored activities or events.

Cancellation by P3 Forum - Any member who, in the sole determination of the Executive Director(s), is found to be in violation of the Member Policies may be suspended or terminated and their payment will not be refunded.

SECTION IV. NOTICES

Any notice from P3 Forum to Members shall be delivered to the email address provided below or as later changed by written notice when received by P3 Forum.

SECTION V. DISPUTES

Any disagreement, difference, or dispute over the meanings of any provision(s) of the Membership shall in the first instance be resolved by the parties themselves in a friendly manner. Failing this, it shall be governed by, construed, and interpreted in accordance with the laws of the State of New York, as operable in good faith as the final resort.

EFFECTIVENESS AND INTERPRETATION OF AGREEMENT

This Special Measures Agreement sets forth the entire understanding of above mentioned agreement and unless otherwise stated is not inclusive of any oral or prior written agreements. Your signature below serves as a complete understanding and agreement to all terms and conditions.
